#### **Chief Tutor (Driving) report**

- RT reported he had been in post for 18 months his role to recruit and coordinate tutors. Thanked EJ for his support
- RT explained the need for advanced tutors and confirmed that two members had completed this training
- On the Isle of Wight plans for training a further two advanced tutors is underway; the
  existing RoSPA car examiner to act as trainer with an assessor approved by RoSPA
  national office coming across from the mainland
- Very grateful to all the tutors for their ongoing support to the group





#### **Chief Tutor (Riding)/Group Chairman combined report)**

- GE thanked EJ and committee for support.
- Succession planning is essential; members are encouraged to contact GE if interested in a role within the group
- Strategic objectives set at last AGM being implemented including performance indicator of 2% growth. Currently 5 advanced tutors and 10 tutors
- Strategic partnership has been formed with Thames Valley
- Slow riding course (new initiative) is set for 10 June (subject to funding approval from the committee)
- Attendance planned at next Sunday's event at Sammy Miller Motorcycle Museum
- Initiatives previously agreed to raise profile of the group business cards, branded high viz vests, pop-up banners now implemented
- Facebook page updated need a volunteer to manage this
- Investing in people (IIP) £1,500 has been set aside for tutor development
- As part of IIP, the tutor group recently completed a 3 day Tutor Development weekend in Tiverton and surrounding areas with a focus on personal riding skill development and discussing group procedures
- Guest speakers needed especially for winter meetings for which help is sought from membership
- Aiming for at least one in-person social evening for combined cars and bikes groups


