3. In line with ROSPA Guidance notes of 2014, a discussion took place regarding various alterations/additions to the current RoADAR Constitution. Some items need further exploration via ROSPA HQ in terms of definition. This enquiry will be made by the Secretary, who will then re-draft an up-dated Constitution for Committee approval.

4. Current Balance in the Account is: £2678.38. The main expenditure has been the previously approved purchase of radios for motorcycle section -. The meeting ratified this expenditure

5. Chief Tutors Reports:

Motorcycles:-

- a. Lilian reported that the purchase and use of the radio's has been well received.
- b. A facebook page has been set up for motorcycle members.
- c. Andy will be arranging a motorcycle run out to Goodwood on 29th March 2015.
- d. There has been one recent 'test' pass obtaining a gold award.
- e. One new applicant is in the process of being allocated to a tutor.
- f. Lilian maintains regular contact with motorcycle members, thus improving communication.

Cars

- a. There have been four new car members joining the group this year
- b. There has been one recent test pass, obtaining a Silver award.
- c. There are no membership candidates awaiting allocation to tutors.
- d. The examiner Phil Pentelow has offered to provide some info/training input to the group.
- 6. A further discussion took place regarding possible activities/events that might be possible over the next six months. Venues could include Mendez Marine or Sarisbury Community Centre, available for a very reasonable cost. Suggestions were made about features that had taken place in the past, and some new ideas of interest were generated in the receding short time available at this meeting. The institution of a small working group to take any plans forward was proposed, but without any final resolution. The Chairperson recommended that all matters be further considered and ideas brought back to the next committee meeting to firm up for implementation.
