## 1. Pathway Presentation

Paul Moignard (Car Tutor) joined the meeting and gave a very useful and thought provoking presentation on 'Creating a pathway to reduce fatalities and serious injuries on our roads'. The aim being to stimulate thinking in respect of young drivers and riders, who account for a major part of road accident statistics. It was acknowledged that action needs to be taken - nationally, locally and by the involvement of Road Safety Groups. Hants RoADAR Group will continue to explore the means within which to play a part, given the Group's limited resources to address this important issue. ## 1. (b) Group Display Material:
